Presentations

Hammond River Holdings – Glenvale Gypsum Quarry Project Manager Daniel Guest attended the meeting to share details with Council on progress at the Glenvale Gypsum Quarry located off of Route 890 in Ward 1, The Community of Three Rivers. Topics discussed included an update on construction, upcoming transition from the construction to operational phase, monitoring strategies for community concerns with respect to air quality, blasting, water quality, pre-blasting surveys of homes located in a 600-meter radius around the blast area, trucking routes, schedules, as well as concerns regarding road conditions. As per the New Brunswick Mining Act, he requested Council provide a letter of consent that Hammond River Holdings proceed with the activities pertaining to the extraction and processing of gypsum at the Glenvale site. Council had no objections to providing a letter of consent.

Works Department – Adam McKiel Works Department Manager Adam Mckiel attended the meeting to discuss current and proposed projects for the municipal works department summer 2024. Some topics discussed were asphalt projects, ditching, repair of the river trail, flower beds in the downtown area, pool preparation for the 2024 season, basketball & pickleball courts, the community garden, repairs of lawns from snow removal damage, and status of works equipment.

Business Arising from The Minutes

Residential/Industrial Development A letter was received from Plan 360 with respect to a property located on Russell Street that is being considered for conversion to a multi-unit dwelling. They requested Council review the proposed development and note any concerns with respect to sewage, parking, and water supply. The sewer lines were previously checked and approved by the works department for increased capacity, the parking plan showed adequate parking however Council did have concerns with one well servicing multiple units and asked that Plan 360 be consulted on how to address this concern.

Library Update Council received an update from Englobe Engineering outlining details of the upcoming comprehensive study for the Church repurposing project which will begin at the end of May 2024.

EMO Update Mayor Saunders reported he has a meeting with the protective committee from the Regional Service Committee on June 14th and will report back any findings at the next regular council meeting.
