CN Rail Line ATV Club Request – Councillor Murphy made a presentation to Council outlining requests of the ATV club on two issues: to create by-laws that would enable them to travel along certain roads and or crossroads within the Community of Three Rivers to hook up existing trails enabling them to legally travel from Havelock to Elgin and beyond. As well, they are requesting Council move forward with purchasing a parcel of land from CN in Petitcodiac which would enable the club to then take ownership of the train bridge and use it as part of their trail system. Council requested inquiries be made with CN regarding the details of purchasing the parcel of land in the village and that research be done to see what is required to enact by-laws to allow ATV traffic on public roads.

Car Show Request

Councillor Hall-Middleton made a motion that the Community of Three Rivers support the Codiac Classics Car Club by providing barricades, garbage cans and washroom facilities for their annual car show to be held in the downtown core on Sunday July 23, 2023. Seconded by Councillor Murphy.

Correspondence

Letter Re: Local Businesses & ServicesCouncil received a letter from a concerned citizen regarding a local business that was closing on Main Street. The letter indicated that they felt it is up to council to promote new business and to be visibly seen supporting them. Council noted the resident's concern. It also expressed concerns that local transportation is not available for those that want to travel to support local business if they do not have a vehicle. Councillor Hall-Middleton noted that Rural Rides is available for medical appointments and the local grocery store will deliver orders for a small fee.

Letter Re: Upcoming Entertainment EventCouncil received two letters that were cc'd to Three Rivers with concerns regarding an upcoming entertainment event being hosted by a local organization in Petitcodiac. Council acknowledged the concerns and felt it was the organizations decision to make changes if they saw fit to do so.

Public Works & Transportation, Sewer DepartmentCouncillor Lymburner asked council to consider purchasing the leased payloader for the works department as their aging equipment is costing more to maintain and that the current equity (lease payments) can be used in the purchase agreement. He also noted that a payloader may not be available for lease for the upcoming snow removal season as such equipment is difficult to obtain. He presented quotes for Council's consideration. No decision was made, and it was noted this would be an item for consideration at budgeting meetings for 2024.

Councillor Murphy reported

- arena staff has begun the process of removing the ice for the upcoming summer season
- discussions will soon take place to make arrangements for this year's pool opening

Environmental Health Councillor Lymburner questioned if there are any plans to start looking at replacing aging infrastructure with respect to the wastewater system. It was noted there are no plans in the immediate future but this can be a topic of discussion in the upcoming long term planning meeting.

Community Development

Councillor Hall-Middleton reported:

- The Maple Street Park Committee was successful in receiving a grant for the Disc Golf project in the amount of \$9850. The estimated cost of the project is \$15,000 and they will be asking for sponsors and donations to secure additional funds.
- The Community of Three Rivers Facebook page is up and running
- The Community Garden is accepting requests for garden plots and raised boxes for the upcoming growing season
- The Community Yard Sale will be held the last week of May 2023. The cost is \$10 to get on the map with all proceeds going to Cystic Fibrosis.
- The Community Garden will be partnering with the Student Essential Skills program at PRS and will be working on a project for the garden
- There will be a workshop on Fraud 101 at the Maritime Motorsport Hall of Fame on April 15th from 10am to 12 pm

• The Garden Club is requesting a street light be put in a the end of Maple Street. Councillor Lymburner will take a look at it to determine what would be the required wattage for that area.

EMO Councillor Hall-Middleton attended a webinar on April 5th regarding EMO.

Regional Service Commission

Mayor Saunders reported he attended a conference for the board members of the Regional Service Commission hosted in Miramichi. Discussions were held regarding the provincially mandated services to be taken on by the Regional Service Commissions and how they will affect municipalities: Economic Development, Community Development, Regional Tourism, Recreational Infrastructure Cost Sharing, and Public Safety. He also reported on the regular monthly Regional Service Commission meeting. He reported he has taken a position on the Protective Services and Planning Committee and Deputy Mayor Murphy on the Recreational Infrastructure Cost Sharing Committee.

- Mayor Saunders attended meetings with legal counsel regarding ongoing litigation
- CAO Sandra Kelly reported interviews will take place for the Admin Assistant position next week
- Councillor Hall-Middleton reported she took part in an online meeting outlining details of the upcoming Needs Assessment for the Salisbury/Petitcodiac area.
- CAO Sandra Kelly reported she will be attending the annual AMANB meeting to be held in Edmunston
- CAO Sandra Kelly reported members of the Library Board would like to set up a meeting with her and the Regional Director regarding requirements with respect to an engineering report on a potential new location for the library.
