### **New Business**

#### Motion to Transfer Funds for Railway Avenue Paving Project

Councillor Murphy made a motion that The Community of Three Rivers transfer funds from the Village of Petitcodiac Gas Tax Fund to the General Operating Fund to pay Brown's Paving in the amount of \$64,525.30 for the cost to resurface a portion of Railway Avenue that was not included in the original tender for the Railway Avenue Sewer Upgrade project 2024. Seconded by Councillor Lymburner.

#### Motion to Transfer Funds for Payment – 2023 Freightliner Rescue Fire Truck

**Background:** A motion of Council on July 7, 2022 was made for the purchase of a new rescue apparatus (2023 Freightliner M2-106) for the Petitcodiac Fire Department. The original approved motion authorized a budget of \$515,761 (plus HST) for the Freightliner and financing was secured. Due to an unexpected increase upon invoicing, a \$30,000 overage was funded from the Village of Petitcodiac's Capital Reserve. This motion will transfer those funds out of the Petitcodiac Fire Department's 2024 operational budget back into the Village of Petitcodiac Capital Reserve.

Councillor Murphy made a motion that The Community of Three Rivers transfers \$30,000 from the Petitcodiac Fire Department's Operational Budget to the Village of Petitcodiac's Capital Reserve Fund to replace funds transferred to cover the extra cost of the 2023 Freightliner M2-106 for the Petitcodiac Fire Department. Seconded by Councillor Hall-Middleton.

#### Motion to Transfer Funds from Restricted Bank Account to Operating Fund - 2018 Fire Truck

**Background:** A motion was made in December 2023 that The Community of Three Rivers transfer insurance proceed funds in the amount of \$174,410 from the General Operating Fund to a restricted bank account for The Community of Three Rivers. The insurance funds were from the loss of the 2018 Fire Truck in a motor vehicle accident and must be held to pay the annual Municipal Capital Borrowing Board Debenture No BR 36-2017 for the duration of the loan up to and including 2027.

Councillor Murphy made a motion that The Community of Three Rivers transfers \$42,407 from the Restricted Bank Account, (containing insurance proceeds from the 2018 Freightliner that was written off in a motor vehicle accident), to the Community of Three Rivers Operating Fund for the 2024 payment to the Municipal Capital Borrowing Board Debenture No BR36-2017 for the Petitcodiac Fire Department's 2018 Freightliner. Seconded by Councillor Lymburner.
